#### Europcar completes acquisition of Keddy Car & Truck Rental in Belgium

Saint Quentin en Yvelines, 30 June 2006: Europcar, the leading European car rental firm which is 100% owned by Eurazeo, today announced it had finalised the acquisition of 100% of the share capital of Keddy Car & Truck, the leading short term car rental outfit in Belgium, from LeasePlan Corporation. This announcement follows the one made on 1 June 2006 stating that Europcar had entered into exclusive negotiations with LeasePlan Corporation to acquire Keddy.

With the acquisition of Keddy, Europcar is reinforcing its presence in its different client segments - both trade and leisure - and becomes the leading tourist and commercial car rental firm on the Belgian market. Europcar intends to keep the Keddy and Europcar brands separate in Belgium.

#### About Keddy

In 2005, Keddy had a turnover of about EUR26 million with a fleet of 3,400 vehicles and a network of nine branches in Belgium. Primarily catering to trade clients (rental to long term leasing firms awaiting new vehicles, replacement vehicles, corporate clients).

#### About Europcar

A subsidiary of the French investment company Eurazeo, Europcar is the leading European car rental firm. The Europcar network includes more than 2,900 rental agencies in over 147 countries. In 2005 with an average fleet of more than 220,000 rental cars and vans and with close to seven million hire contracts, Europcar had revenues of EUR1.28 billion, up nine per cent versus 2004. The Group has 5,200 employees.
